


## Visible Opaque Dyes

Epolin Visible Opaque dyes are well suited to aesthetically hide cameras and sensors by masking them with a visibly dark, opaque color. These devices are still able to operate in the infrared space with very high transmission through the material.






By combining Visible Opaque dyes along with NIR dyes it is possible improve signal to noise ratios and build filters that enable the camera or sensor to see the environment without ambient noise.

These products are known as near infrared cut-on filters or long wavelength band-pass filters. They are designed to block UV and visible light while transmitting NIR light.
